DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#201 Phebus is a detached 2-1/2 story, small frame house, possibly of logs, two bays wide and one bay deep with a newer two story frame rear addition extending four bays across from the left wall and one bay in depth with a right side front balcony. The building is sheathed with German siding.

A newer door occupies the right (east) bay and is fronted by a covered porch with turned pillars. All windows are of small 1/1 sash and the attic is lighted from the right gable by a small window.

The house has a moderate slope "A" frame metal roof and the wing roof is rather flat with a small chimney rising at the rear of the front section.

The front section probably rests on a low fieldstone foundation and the wing sets on a concrete block foundation.
