**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#101 is a 2-1/2 story brick house detached on the right side, two bays wide and three bays in depth with a 2-1/2 story half of a "T" shaped wing, approximately 1-1/2 bays wide and two bays in depth and an enclosed side balcony. All brickwork is in common bond. The simple entrance occupies the left (south) bay with a newer door and most windows are of 6/6 with wood lintels and sills. A small four pane window lights the attic from the right side.

The front section has a steep slope "A" frame metal roof resting on two string brick cornices. The remains of small chimneys rise from each end and above the wing which has a steep metal shed roof.

This house has a fieldstone foundation.
