**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#103 is a 2-1/2 story brick house detached on the left (south) side, two bays wide and approximately three bays in depth with a two story, 1/2 of a "T" shaped wing approximately 1-1/2 bays wide and one bay in depth and with a rear balcony. All brick-work is in common bond.

A simple entrance occupies the left bay with a newer door and two pane overlight. Most windows are of 6/6 sash with wood lintels and sills. A small four pane window lights the attic from the left side.

The front section has a steep metal "A" frame roof, slightly lower than its twin at #101, and it also rests on two string brick cornices. The remains of small chimneys rise from each end. The wing roof is rather flat.

The house rests on a fieldstone foundation.
