DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story building occupying a corner site, constructed of narrow red brick laid in common bond. Its two facades are identical, two bays in each, framed by brick pilasters. The corner of the building facing the square has been cut off skew and has a bay window (the glass being closed up with wood panels) at the second and third stories.

The first story fronts have been recently remodeled with glass windowalls with brick between. The entrance is on the corner and is recessed. Originally, a brownstone base ran around the building at sidewalk level, but has been covered up for the most part by the remodeling.

The second and third floor bays each have three double hung windows 1/1 sash with transoms. A brownstone sill and lintel is continuous in each bay. The sills and lintels are moulded at the second story level, but at the third, the sill is simpler and the lintel is just a block. A recessed brick panel divides the second and third floor windows. The brick pilasters are corbelled out from the original brick wall at about the first floor ceiling level. There is a panel of patterned brick in each bay above the third story windows corbelling out flush with the surface of the pilasters so that the whole bay appears to be a recess.

The entablature on the building consists of a small wood architrave, a brick frieze which is part of the wall, and a simple wooden cornice with square modillions. The roof on the entire building is flat and there is a low chimney on the northern corner of the Market Street facade.
