DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached pair of 1-1/2 story brick cottages five bays wide and two bays in depth with small one story brick "T" shaped kitchen wings centered behind each house. Very old soft bricks are laid in common bond. There is a wide enclosed passage to the rear through the center of the building and simple four panel doors lie on either side protected by small ground level porches with peaked roofs.

There are 4/2 sash windows on the first floor with paneled shutters secured by wrought iron hardware and small 6/6 sash windows light the attic from the gables. All have wood lintels and sills. There are also picturesque small peaked dormers on the front.

The building has a moderate slope "A" frame roof covered with asphalt shingles and a small chimney rises from the rear of #9. Log beams support the attic floor.

This structure probably rests on a low fieldstone foundation, but is not visible.
