DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story structure of five bays wide with the three south bays divided into a second house during the late 19th Century. This is three bays in depth and has a two story "T" shaped wing being two bays square with balconies on either side. It is detached on the south side. The front section has a steep slope "A" frame metal roof with wide chimneys enclosed in the gables. The wing has a very low sloping metal "A" frame roof with a chimney in the end. All brickwork is of common bond. The front doorways occupy the center and second from the north bays. They have paneled doors with two pane rectangular overlights and are approached by a double concrete porch of nine steps and with iron railings. Since the building is on the side of a hill, #104 has a very high basement with the fieldstone foundation rising up about 4' from the pavement. On the front section, all windows are 6/6 sash wity flat jack arches on the first floor and regular flat brick arches on the second floor. #104 has louvered shutters and also two small 6/6 windows in the gable on either side of the chimney. Wing windows are either small 6/6 sash or small 9/9 sash and with no lintels or arches. The front cornice is a simple box type with modillions and a row of moulding protruding from the frieze. The cornice on the rear is also of a simple box type edged with moulding. A watercourse of one row of convex moulded brick **B** extends along the front and is over 7' high from the pavement on the lower s/w corner. This is said to be an 18th century type of brick moulding per research of Mrs. Crist at #106. The wall projects from the watertable to the pavement.
