DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This small house was built as an office annex to #106 N. Bentz Street for the grain mill across the street at that time. It is 2-1/2 stories in height, two bays wide and one bay deep being detached on the north side and has a small, two bay long and one bay wide "L" shaped wing built at a later date. The front section and wing both have a steep sloped "A" frame asphalt shingle roof with enclosed chimneys in the north and east gables. All brickwork is of common bond. The front door occupies the south bay and is paneled with a four pane, rectangular overlight. This is reached by a six step brick porch with an iron railing. All front windows are of 6/6 sash with one course header flat arches. The front cornice is a simple box type supported by small bracket-shaped modillions closely spaced on the frieze. A watertable runs along the front wall and is composed of the projecting wall up to a distance of about four feet from the pavement, including the fieldstone foundation.
