DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick detached pair of houses being four bays wide and approximately three in depth with a newer, one story frame extension. All brickwork is in common bond.

There are four panel doors in the first and third bays from the left side. Windows are of 2/2 sash with two row header brick segmental arches. The attics are lighted by four pane windows in the gables.

The steep sloped "A" frame roof is of metal and rests on two string brick cornices. Small enclosed chimneys rise from the center and at the right gable.

The building rests on a fieldstone foundation.
