DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#320 is a 2-1/2 story brick house detached on the left (north) side approximately three bays square with a small rear balcony and a newer, one story frame extension. All brickwork is laid in common bond and the rear wall is angled on the north end for no apparent reason.

There is a newer door in the right bay with a two pane transom. To the left is a tall, double 1/1 sash window with the mullion grooved and moulded. Upper front and rear windows are of 2/2 sash and all fenestration is headed by segmental brick arches with very ornate incised infills. Small four pane casement windows light the attics from the gables.

The house has a moderate slope "A" frame roof of asphalt shingles resting on two string brick cornices with the top row being in dentil form on the front. Small enclosed chimneys rise from each end. The low foundation is most probably of fieldstone but is not visible.
