DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#322 is a small frame, two story house, formerly of 1-1/2 stories, two bays wide and one in depth detached on the right (south) side. Attached to the rear is a one story shed roofed wing and a small, one story frame extension. The front section is sheathed with German siding and rear areas are covered with asphalt shingles.

A four panel door occupies the right bay with a 6/1 sash window on the left and 6/6 sash windows above. A large shed roofed dormer window lights the attic from the rear.

The building sets on a fieldstone foundation.
