## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#324 is a small 2-1/2 story brick house detached on the left (north) side. It is two bays square with a 2-1/2 story brick "L" shaped wing one bay wide and two bays in depth with a side balcony and a newer two story frame extension. All brickwork is in common bond. A newer door occupies the left bay and all windows are of 6/6 with wood lintels and sills except for old four pane casement attic windows.

The front roof is of moderate slope "A" frame construction covered with metal and rests on two string brick cornices. A small enclosed chimney rises on the right side. The wing has a metal shed roof.

This building rests on a fieldstone foundation and is fronted by a brick pavement.
