**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This warehouse is a tall, detached, 3-1/2 story brick building, five bays wide and four in depth. A rear "L" shaped, two story extension of the building now lies in ruins, apparently the result of a fire. All brickwork is in common bond.

Front and side bays are accented by brick piers and the recessed bays are corbelled in from the base of the walls.

Front entrances occur in the second, third, and fifth bays from the left (North) side, with double doors of diagonal boarding, rounded transom bars, and five pane overlights. These entrances are serviced by a long narrow wood platform and corrugated metal roof.

There are two double windows of 6/6 panes on the first floor of the front and all others are of wide 6/6 sash. All windows and doors are headed by segmental, three row brick header arches. The top half story is lighted from the gables by round arched 6/6 windows and there are brick panel "fake windows" on the front.

The building has a low slope, metal, "A" frame roof. The front facade and third story side elevations are decorated by corbelled brick dentils in a design of four sketches.

The structure rests on a low fieldstone foundation.
