DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This large, rectangular, three story brick warehouse is four bays wide and ten bays in depth with no wings. All facades are laid in small, pressed brick in common bond. The front and both sides are trimmed by wide brick quoin sections at all corners and by a brick belt course in a dentil design just below the roofline parapet walls.

The high front doorway is round arched with four rows of header bricks and occupies the right (North) bay. It is protected by a pull down flexible metal door.

The front facade contains 6/6 sash windows in the first two stories and small six pane windows in the top story, which also *fenestrate* both side walls. All windows are headed by two row header brick segmental arches.

This structure appears to have a flat roof surrounded by the parapet walls. It rests on a fieldstone foundation.
