DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story brick detached factory building four bays wide and eight bays in depth with one and two story rear extensions, a right side covered loading platform, and two, two-story brick extensions of two and three bays and a three bay block extension, all to the left (South) of the original plants. These extensions are of various depths.

The main office door occupies the second bay from the right, and although of only ordinary size, it is multi-paneled and formerly contained a transom. The first floor of the original front facades is lighted by attractive double windows of 2/2 sash with five pane transoms. Above are regular 1/1 sash windows, some bricked in. All fenestrations are headed by two row segmental header brick arches.

The flat roof supports several small structures and is fronted by a parapet.

This building and the first two left side extensions rest on fieldstone foundations.
