DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is an extremely simple store building now divided into two stores. It is essentially a one story structure, but the front is carried up to a second story height. The main structural material is red brick which can be seen on the side, but in front is a metal and glass storefront with white and pink marble facing on the corners and above the display windows. The roof is flat and the sidewalls have parapets which run above the roof level.
