## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story detached pair of brick homes, five bays wide and approximately three bays deep with two story brick "U" shaped wings, three bays long and two bays wide with end balconies. All brickwork is in common bond.

Front entrances occupy the end bays with five panel doors and rectangular transoms and are approached by white marble sills and four step cement porches.

All front windows are wide 1/1 sash with mostly wood lintels and sills. An enclosed passageway to rear yards occupies the center bay, headed by stick grillwork. Attics are lighted by small, four pane windows in the gables. Rear windows are of 2/2 sash with two row header segmental brick arches.

The moderate slope "A" frame metal roof rests on two string brick cornices with the front being of moulded bricks. Rear metal roof sections slope inward. A square enclosed chimney rises  from the center of the ridge.

This building rests on a fieldstone foundation and is fronted by a brick pavement.
