DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#208 is a 2-1/2 story detached frame house sheathed with asbestos siding. It is three bays wide and three larger bays in depth with a two story frame wing two bays square and a side balcony.

The front entrance occupies the right (South) bay and all windows are of 2/2 sash and a small four pane window lights each gable.

The moderate slope "A" frame roof is of metal and is fronted by a boxed cornice. A small enclosed chimney rises from the left gable.

This house rests on a fieldstone foundation.
