## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached pair of 2-1/2 story brick houses four bays wide and two bays in depth with a two story, full width brick wing, one bay deep and with rear balconies. All brickwork is in common bond, but #212 has been refaced with imitation brick.

Front entrances occupy the center bays with newer doors and most windows remain 6/6 sash with wood lintels and wood or newer brick sills.

The moderate slope "A" frame roof is sheathed with metal and rests on two string brick cornices. A small enclosed chimney rises from each end. The wing roof is of a low slope "A" framing. This building rests on a fieldstone foundation.
