DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached pair of 2-1/2 story brick houses four bays wide and two in depth, with a two story brick, full width wing one bay deep and with rear balconies. All brickwork is in common bond and appears to be very old and crumbly.

Front entrances occupy the inner bays with newer doors. Front windows are of 2/2 sash and rear windows are of wide 6/6 sash, all with wood lintels and wood, or newer, brick sills. Attics are lighted by small four pane windows.

The front section has a moderate slope "A" frame metal roof resting on two string brick cornices. Small enclosed chimneys rise from each end.

This building rests on a fieldstone foundation.
