## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached pair of two story brick houses four bays wide and four longer bays in depth with no wings, but rear balconies. All brickwork is probably in common bond with the side wall of #220 stuccoed and #222 is sheathed on the front and sides with aluminum siding.

Front entrances occupy the inner bays with newer doors and windows which are of either 2/2 or 6/6 sash with two row header segmental brick arches.

The metal roof slopes to the rear ending in a low "A" frame and is fronted by a boxed cornice trimmed with dentils and cut brackets.

The building rests on a fieldstone foundation.
