**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a detached 2-1/2 story frame house three bays wide and approximately five bays in depth including a lower rear bay. The house could be the oldest structure on the block as it sets behind the building line of others on the block. It is sheathed with asbestos siding.

A simple three part entrance (side lights & overlights) occupies the left (North) bay and the first floor is fronted by an elaborately ornamented Victorian porch with spindle decor and turned pillars.

The gable faces the street and is decorated at the peak with scroll saw ornamentation suspended from the "A" frame boxed cornice.

Most windows are of 2/2 panes. A bay window with a peaked roof accents the left side corner and a square enclosed chimney with ornamental brickwork rises to the right.

The "A" frame metal roof is of moderate slope.

This house appears to be resting on a brick or block foundation as no rough stonework can be detached.

An attractive cast iron fence adorned with foliage and garlands, guards the front lawn area.
