DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached pair of 2-1/2 story frame houses four bays wide and three in depth with a full width, two story frame wing two small bays in depth and with rear balconies. The building is sheathed with asbestos siding.

Very plain entrances occupy the first and third bays from the left (North) side. All house windows are of 2/2 sash except for the double 1/1 sash windows in the first floor front.

The front section has a moderate slope "A" frame roof of metal with plain boxed cornices and small square enclosed chimneys rise from each end. The wing is topped by a low "A" frame metal roof.

The building rests on a fieldstone foundation.
