DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached pair of 2-1/2 story frame houses four bays wide and two bays in depth with a 2-1/2 story frame "T" shaped wing three bays wide and one in depth with a first story high rear covered porch. Beneath this lies a ground level entrance to the cellar. The building is sheathed with "German" siding. Simple entrances occupy the end bays and all windows are of 2/2 sash.

The roofs of the front section and wing are of metal and of moderate slope "A" framing with plain boxed cornices and a small square chimney rises from the center of the front ridge. The building rests on a low fieldstone foundation and is fronted by a brick pavement.
