DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached 2-1/2 story pair of frame houses four bays wide and two in depth with a full width 2-1/2 story wing one bay in depth. The building is sheathed with "German" siding.

Simple front entrances occupy the end bays. Front windows are of 2/2 sash and those on the rear are of 6/6 sash. Small four pane windows light the attic.

The "A" frame roofs are of moderate slope and are of metal, being edged with simple boxed cornices. A small square chimney rises from the center of the front section ridge and from the wing.

This building rests on a fieldstone foundation and is fronted by a brick pavement.
