DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached pair of two story brick houses four bays wide and four larger ~~bays~~ bays in depth with no wing or balcony. All brickwork is laid in common bond.

Simple entrances occupy the end bays with rectangular transoms and wood lintels. All windows are of 2/2 sash with wood lintels and sills.

The metal roof slopes to the rear and is fronted by a simple boxed cornice.

The building apparently rests on a brick or block foundation.
