DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story detached pair of frame houses four bays wide and approximately four longer bays in depth, #246 having a 2-1/2 story full width wing two bays deep and a two bay extension. This is all sheathed with metal siding. #248 has a 2-1/2 story "L" shaped wing, one bay wide and two bays in depth with a side balcony. This house is sheathed with asbestos siding in a brick design.

Newer doors occupy the end bays. All windows are of 2/2 sash and the attics are lighted by pairs of small four pane windows.

The front section metal "A" frame roof is of moderate slope and small square chimneys rise from near each end. The metal wing roof appears to be of a steeper slope. These are edged by plain boxed cornice.

The material of the foundation walls is not discernable.
