DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached two story brick house two bays wide and approximately five bays in depth with an end balcony. All brickwork is in common bond.

The simple entrance occupies the right (South) bay and is headed by a rectangular transom. A full width covered porch ornaments the front facade with cut brackets and turned pillars. All windows are of 1/1 sash and are headed by two row brick header segmental arches, as above the doorway.

The roof is of metal and slopes to the rear. This is fronted by a boxed cornice decorated with dentils and scrolled brackets.

The house apparently rests on a brick or block foundation.

There are neatly tended front and side lawn areas.
