DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#5 is a small, detached, two story frame house, three bays wide and two in depth with a two story, frame, two bay square "L" shaped wing. This is said by the owner to be of log construction, and it is now covered with composition shingles. A newer door occupies the left front bay, and all front windows are of small, 6/6 sash. Side and rear area windows are either small, 6/6 or 2/2 sash, and there is a board and batten rear door. Roofs of both front and wing sections are of a very low slope and covered by metal. The front roofline is now adorned by a Victorian moulded cornice decorated by closely spaced, intricately cut, scrolled brackets. This house rests on a low fieldstone foundation. There is a small rear patio garden. A wood framed, closed small stairwell with a board and batten door leads to the second floor from the side hallway. The wing level is two steps higher than the front section.

Log beams covered with bark support the house.
