DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#9 is a high, brick, 1-1/2 story house detached on the left (W) side and is three bays wide and two bays deep with a 1-1/2 story, brick "L" shaped wing, two bays in depth and 1-1/2 bays wide. All brickwork is in common bond. The simple front entrance in the center bay has a newer door, a four pane glass over-light and a wood lintel and sill. First floor windows are now of 2/2 sash with a side 6/3 sash and the rear area has small 6/6 sash windows. Top story "lie on your stomach" type windows have been changed from original casements to newer sash on the front and rear, and all have wood lintels and sills. The front section has a steep slope "A" frame roof resting on three string brick cornices and with small enclosed chimneys rising from each gable. The wing has a steep shed roof and both are of metal. This house sets on a high foundation with cellar walls of brick on a pavement level, fieldstone foundation. Old board and batten doors lead to the cellar, and there is a brick pavement along the front.
