DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached pair of two story brick houses, six bays wide and three in depth with a two story, brick "T" shaped wing, four bays wide and two deep with side balconies. All brickwork is in common bond. Simple front entrances occupy the center bays with four panel doors with top panels rounded, granite sills and narrow overlights. All front windows are of 2/2 sash and rear windows are 6/6 sash, all with wood lintels and sills. The front section roof slopes to the rear and the wing has a low "A" frame. The front roofline is adorned with a moulded wooden cornice, curved modillions, roundels, and an elaborately crafted frieze with a ballustrade of attached, turned banisters ended by a band of projecting pyramidal blocks. Large moulded brackets accent the ends. The building rests on a low fieldstone foundation. #16 retains a herringbone patterned brick pavement.

This pair of houses appears to be an evolutionary stage of the two story, brick house in Frederick as the doorways are centered, and it has wood lintels on the front rather than the round and segmental brick arches of a later date, popular in downtown Frederick.
