DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#17 is a tall, 2-1/2 story brick house detached on the right (E) side and is three bays wide and two bays in depth with a newer, two story block and frame wing. The front facade is laid in Flemish bond, the only example of this for this block. The front entranceway occupies the left bay with a large, four panel door with top panels rounded and a segmental arched transom with an unusual transom bar fronted by an attached, turned, horizontal banister. The whole is framed by a rounded, moulded architrave. All front windows are of 1/1 sash with wood lintels and sills. The attic is lighted by a small, four pane window in the right gable. The front section has a steep sloped, "A" frame metal roof resting on three string brick cornices and a wide enclosed chimney rises from the right side. This house sets on a high fieldstone and brick foundation.
