**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#18 is a large, 2-1/2 story, frame, detached house, four bays wide and two bays deep with a two story, frame, "L" shaped wing, one bay wide and four long with a side balcony. The building is covered by clapboarding. A four panel door with an overlight occupies the second bay from the left (E). Front windows are 2/2 sash with louvered shutters and the rear area has 6/6 sash with four panel doors. The roof of the front section is of steep "A" frame construction with enclosed double flue chimneys rising from each end. The attic is lighted by small, four pane windows in each gable. The wing has a shed roof and both are of metal. This house rests on a low fieldstone foundation. It is fronted by a brick pavement.
