**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a detached pair of small brick houses, two stories high, four bays wide and three bays deep with no wing. Brickwork is of unpainted common bond. Simple doorways occupy the outer bays. All house windows are of 1/1 sash with two row header brick arches as over the doorways. The metal roof slopes to the rear and is fronted by a simple boxed cornice. The building rests on a low foundation. It is fronted by a brick pavement.
