**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

As is the case with the neighboring building No. 17, there is little to be seen of the original structure at No. 19. The first and second floor fronts have been covered with a metal and glass storefront and signplate. To the north of this storefront, there is a doorway with a six pane transom. Above, on the third floor, the original construction can be seen. It is brick painted gray with gray trim and a flat roof. The third, the uppermost, floor is three bays wide with double hung windows with 6/6 sash having plain wood sills and small straight cornices over. The building's cornice has an unusual row of consoles under the cornice proper - the consoles being in a one to one correspondence with the modillions in the cornice above. The whole cornice is returned around the south wall of the building for a distance of approximately three ft. In that south wall towards the center of the building is a brick chimney.
