DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#26 is a two story, brick house, three bays wide and two deep with a two story, brick "L" shaped wing, four bays long and two wide with a side balcony. All brickwork is in common bond. A newer door with a round arched transom occupies the right (W) bay and to the left is a wide, elliptical, arched, double window with fluted mullions topped by roundels. Second story windows are segmentally arched with segmental arched, louvered shutters and all house windows are of 1/1 sash. Rear area windows are of the same design. The front doorway is entered by an old fieldstone slab step. The front section roof slopes to the rear, and the wing has a shed roof, both of metal. The front Victorian cornice is in a "V" shape of moulding and bands of dentils and half spheres ended by scrolled brackets topped by acroteria bearing roundels. The house rests on a low fieldstone foundation.
