DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story, frame, detached pair of houses, four bays wide and three in depth with a one story, frame "T" shaped wing, one bay deep and three bays wide, all covered by brick patterned tar paper over clapboarding. Entrances occupy the front outer bays with #28 a newer door and covered porch with #30 retaining an old, four panel door and overlight. Windows are of 2/2 sash. The front section roof slopes to the rear. It is fronted by a boxed cornice with a slanted band of incised crosses. The building rests on a low fieldstone foundation and is fronted by a brick pavement.
