DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a high, two story, frame pair of houses, six narrow bays wide and two in depth, detached on the left (W) side and with various shaped extensions. #31 has a one story, small frame extension and #33 has a 1-1/2 story brick and frame extension, one bay deep and three bays wide with a steep side sloping shed roof. Front and rear sheathing is of asphalt shingles, and the left side has an embossed brick design metal covering. Four panel doors occupy the inner, off-centered bays, and all house windows are of small, 6/6 sash. The front section has a steep "A" frame roof covered with asphalt shingles and with double flue enclosed chimneys rising from each end. The attics are lighted by two small, four pane windows in the left gable. An ornate English chimney pot rises from the extension of #33. This building sets on a high fieldstone foundation.
