DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a pair of 2-1/2 story brick houses detached on the right (E) side, approximately five bays wide and two in depth with "U" shaped wings of brick, 1-1/2 stories, one bay wide and two deep. There is a newer, one story extension on #35 and a newer, brick, top story with a side balcony added to the wing of #37. All brickwork is in common bond. Simple front entrances occupy the outer bays with newer doors and a high enclosed passageway to the rear yards is in the center. Front windows of #35 are of 1/1 sash with 6/6 sash on the rear. #37 has 3/1 vertical sash on the front and mostly 3/1 on the rear, all with wood lintels and sills. The attic of #37 is lighted by a small, four pane window in the right gable. The front section has a moderate slope "A" frame roof with a three string brick cornice on the front. Enclosed, double flue chimneys rise from each end. The wings have shed roofs and all are of metal. This building sets on a high fieldstone foundation. #37 retains a brick pavement.
