DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a very small, 1-1/2 story brick pair of houses detached on the right (E) side and is five bays wide and two deep with small, brick, 1-1/2 story "U" shaped wings, one bay wide and two in depth. All brickwork is in common bond. Simple front entrances occupy the end bays with #41 apparently retaining an original, four panel door with top panels now in glass. Both have wood lintels and sills and three pane overlights. These are approached by three step porches. The center bay is occupied by a wide, enclosed passageway to the rear yards. All windows are of 6/6 sash including the peaked dormer on the front roof of each house, and all have wood lintels and sills. The rear wing attics are lighted by small end windows. The front section has a steep slope "A" frame roof with the front dormers, box cornices and a small chimney rising from the right side of each house. The wings have steep slope shed roofs with tall end chimneys, and all roofing is of asphalt tar paper. This old building rests on a low fieldstone foundation. It is fronted by a herringbone patterned brick pavement.

This is a picturesque, little pair of houses of the early Federal period, probably built for laborers. It adds much character to this block and is one of the oldest structures. It is sadly in need of restoration and should be a good candidate because of its solid foundation and basic construction.
