**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a detached, two story pair of frame houses, four bays wide and approximately three in depth with a 2-1/2 story frame "T" shaped wing, three bays wide and two in depth with side balconies. The building is covered with asbestos shingles. Glass over panel front doors occupy the outer bays and most windows are 1/1 sash. There are either small pane windows or louvers in the attic gables. Both house sections have moderate slope, "A" frame roofs of metal. The building rests on a low fieldstone foundation.
