## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, two story pair of frame houses, four bays wide and approximately five in depth with end balconies. Both are now sheathed with asbestos shingles except for the original clapboarding remaining on the rear facade. Period doors occupy the end bays and #108 has a first floor set of double, 1/1 sash windows. All other windows are of 2/2 sash. The metal roof slopes to the rear and is fronted by a boxed cornice, trimmed by a band of dentils. The building rests on a low fieldstone foundation.
