DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#115 is a small, 1-1/2 story, detached frame house, three bays wide and one bay in depth with a one story, frame "L" shaped wing, one bay wide and two in depth. The front facade is now sheathed with asbestos siding whereas the sides and rear area are covered by asphalt shingles. The front entrance occupies the center bay with a newer paneled door and a four pane overlight. This is protected by a small porch with a peaked roof. The two front windows are of old, narrow framed 6/6 sash as in the right gable. The attic is also well lighted by two 6/6 peaked dormer windows on the front roof and two six pane vertical casement windows in the left gable. The left side of the wing has two horizontal, six pane casement windows. The front section has a steep sloped "A" frame metal roof with the two peaked dormer windows. A small enclosed chimney rises from the left side. The house rests on a rather low fieldstone foundation and is fronted by a herring-bone patterned brick pavement.
