DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#116 is a 2-1/2 story, detached, frame house, three bays wide and two in depth with a two story, frame "L" wing, 1-1/2 bays wide and four in depth with a side balcony. The building is now sheathed with asphalt siding. A six panel door occupies the right (W) bay with a narrow overlight. All house windows are of 2/2 sash with louvered shutters. The attic is lighted by small, four pane windows in each gable. The front section has a moderate slope "A" frame roof, small enclosed chimneys rising at each end. The wing has a shed roof and both are of metal. The house rests on a low fieldstone foundation and is fronted by a brick pavement.
