DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, 2-1/2 story brick pair of houses, four bays wide and two in depth with a two story, brick "T" shaped wing, three bays wide and two in depth, side balconies, and an off-centered, two story, frame extension, three bays wide and two in depth. All brickwork is in common bond and the rear extension is sheathed with aluminum type siding. Simple front entrances occupy the outer bays with newer doors. All windows in the front sections are of 2/2 sash with wood lintels and sills, including those in the side gables and in the front pediments. Those in the newer extension are of 1/1 sash. The front facade is capped by two steep roofed pediments, one centered above each house. They rise above a boxed cornice trimmed with dentils which continues around the corners. The pediments and side gables repeat the same trim. The front section has a rather steep slope "A" frame roof with small enclosed chimneys at each end. The wing and extension have low "A" frame roofs and all are covered by asphalt shingles. The building rests on a low fieldstone foundation.
