DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Built as a store in the S. S. Kresge chain, 26 N. Market is an example of a typical store. It is one story for the most part with a very small second story in the front. The facade is built of an off-white brick laid in common bond. The trim is a light gray stone, probably limestone.

Running along at the sidewalk and up about six feet on the front corners is a band of red and black speckled granite. The first floor front consists of three display windows with two pairs of entrance doors. The two display windows of each side have compartments behind them decorated with pilasters in a modified Ionic order.

At the second floor level there are five windows, one at either side with a group of three in the center. Around all of these is a band of stone forming the sills, jambs and heads of the windows. In the upper corners of the three center windows, the band has rosettes placed on it. A stone subsill carries the whole length of the building under the windows below which is a recessed brick panel providing space for a sign. Above the windows, the brick is laid so as to form a diamond pattern.

The building has stone parapets all the way around and both first and second stories have flat roofs.
