DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, two story, brick pair of houses, four bays wide and approximately five in depth with a full-width, one story, newer block extension. All brickwork is in common bond and sidewalls have star design brace terminal plates. Glass over panel doors occupy the end bays with segmental arched overlights. All windows are of 2/2 sash with two row brick segmental arches as above the doors. The metal roof slopes to the rear and is fronted by a moulded, boxed cornice with narrow cut brackets headed by acroteria which divide and end the house lines. This building rests on a low fieldstone foundation. It is fronted by a brick pavement.
