DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, 2-1/2 story frame pair of houses, four bays wide and three in depth with a two story, frame "T" shaped wing, three bays wide and two narrow bays in depth with side balconies. #205 also has a newer, two bay deep frame extension with an end balcony. The building is now sheathed with asbestos siding. Newer doors occupy the inner bays with #207 retaining a narrow overlight and are protected by a covered porch now supported by metal framing. All house windows are of 2/2 sash and the attics are lighted by small, four pane windows in each gable. The front section has a moderate slope "A" frame roof with small enclosed chimneys rising at each end. The wing is rather flat and both are of metal. The building sets on a rather high fieldstone foundation and is fronted by a brick pavement.
