**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a detached, two story, frame pair of houses, four bays wide and approximately five in depth with rear galleries. The building is completely sheathed in clapboarding. Period, small paned doors occupy the end bays, have narrow overlights, and are protected by a wide, covered porch with turned pillars. All house windows are of 1/1 sash and those on the front are trimmed by moulded top lintels.

The metal roof slopes to the rear. The front overhanging cornice is decorated with modillions and small, plain cut brackets divide and end the houses.

The building rests on a low fieldstone foundation.
