DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, 2-1/2 story, frame pair of houses, four bays wide and one in depth with a 2-1/2 story, frame "T" shaped wing, full width, approximately three bays deep and with rear galleries partly enclosed. The building is sheathed by clapboarding on #216 and asphalt siding on #218. Newer doors with narrow overlights occupy the end bays and are protected by a wide covered porch with turned pillars and banisters. First floor front windows are of wide, 1/2 sash with regular 2/2 sash windows above and on the rear. The attics are lighted by small, four pane windows in each side and the end of the wing. The front section has a steep slope, slate "A" frame roof with a large chimney centered on the rear slope. The wing has a moderate slope, metal "A" frame roof. The building sets on a rather high fieldstone foundation.
