DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a Turn of the Century three story brick building, detached on the right side. It is six bays wide and approximately five bays in depth with "U" shaped, two story wings of four bays in depth and two bays wide. #24 has an added one bay deep and two bays wide addition and #26 has a balcony on the rear. The front facade is faced with a deep red pressed brick while the side and rear sections are of regular brick, all in common bond. Front doorways occupy the third and sixth bays from the left. #24 is headed by an ornamental metal canopy. Those doorways have seven recessed steps leading to the first floor. First floor windows are of the large commercial type and the upper floors have round arched 1/1 sash wide windows on the second story and narrow ones on the third. Side and rear windows are of 6/6 and 1/1 sash with brick segmental arches. The doors have high transoms. The front section roof slopes to the rear and the wings have shed roofs, probably of metal. Small chimneys are enclosed in the walls. The roofline is fronted by a rather ornate cornice. It is supported by heavy brackets at each end and embellished with a row of acanthus leaf trimmed modillions and a row of dentils tops the molded frieze which is ornamented by carved garlands. This building rests on a very high field-stone foundation.
